




# Policies should be the safety in the background of foster care workers and foster parents and unaccompanied minors

- We discussed how not to underestimate the realities of being an unaccompanied minor
  - And we probably do...
- We should not underestimate the complexities of being a foster parent
  - And we probably do...
- Strong (therapeutic) foster care can not exist without strong policies and a strong network.
- Resist the tendency to make an individual responsible for the cracks and gaps in the system
- De-institutionalisation
  - Yes, but how to effectively ensure well-being and development possibilities of the child and the durability of a sense of connection and meaning within foster care?



# A robust, multilevel and holistic approach is crucial

- Needed for the support of foster families themselves
- Also true for the foster care department
- And any service in het sector
- But in a sector that is highly
  - Fragmented
  - In survival mode




A global and holistic, rights-bases approach

Promotion of Empowerment and Social and Cultural Integration








# Guardianship

■ Enhanced reception education and Follow-Up






An efficient and child-friendly asylum system


